20	provided, however, that any amendments affecting the
21	funding or funding levels of this contract shall be
22	submitted for further prior approval by this Council.

24	was present with a vote of <u>1,667.0</u> for; <u>-0-</u> against; <u>57.0</u> not voting; <u>03</u> absent, pursuant to the powers vested in the Council
25	by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
26	18. 1986, and approved by the Acting Deputy Assistant Secretary-
27	Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
