

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Community Health Services FY '90 Budget Modification
and Extension)

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Community Health Services Program under an extension of
3 the FY '89 P.L. 93-638 contract with the Public Health,
4 Indian Health Services; and

5 WHEREAS, any amendments affecting the funding or funding levels
6 of the contract shall be submitted for review and
7 approval by the Tohono O'odham Legislative Council; and

8 WHEREAS, the Community Health Services Program has submitted its
9 FY '90 Budget Modification for review and approval; and


10 WHEREAS, the Tohono O'odham Nation does request an extension to
11 the existing contract with Indian Health Services from
12 January 01, 1990 through September 30, 1990; and

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
14 Council that it hereby approves the attached budget
15 modification.

16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
17 that the Tohono O'odham Nation's Officials, to wit: The
18 Chairman, Vice Chairman and any designated official are
19 hereby authorized to negotiate and execute the contract,
20 provided, however, that any amendments affecting the
21 funding or funding levels of this contract shall be
22 submitted for further prior approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 28th day of December, 1989 at a meeting at which a quorum
25 was present with a vote of 1,667.0 for; -0- against; 57.0 not
26 voting; 03 absent, pursuant to the powers vested in the Council
27 by Section 1(f) of Article VI of the Constitution of the Tohono
28 O'odham Nation, adopted by the Tohono O'odham Nation on January
29 18, 1986, and approved by the Acting Deputy Assistant Secretary-
30 Indian Affairs (Operations) on March 6, 1986, pursuant to
31 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
