

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing Expenditure of P. L. 99-503 Funds for Benefit  
of San Lucy Farms)

RES. NO. 41-89

1 WHEREAS, the Farming Authority ("Authority") of the Tohono  
2 O'Odham Nation has assumed management and operation of  
3 the San Lucy Farms acquired pursuant to P. L. 99-503;  
4 and

5 WHEREAS, the Authority has presented a budget for \$59,450.00 to  
6 improve the San Lucy Farms by the construction of  
7 culverts, turnouts, checks, and ditches; and

8 WHEREAS, the San Lucy District Council did by Resolution No.  
9 01-07-89 approve the budget and the expenditure of P.L.  
10 99-503 funds for the purposes therein set forth.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
12 Legislative Council does hereby approve the budget of  
13 the Farming Authority in the sum of \$59,450.00 for the  
14 improvement of San Lucy Farms, and does hereby authorize  
15 the expenditure of such sum by the Authority as an  
16 Economic Development cost from funds available to the  
17 Tohono O'Odham Nation under P.L. 99-503.

18 BE IT FURTHER RESOLVED that only the interest shall be used from  
19 P.L. 99-503 investments to fund the \$59,450.00 .

21 The foregoing Resolution was passed by the Tohono O'odham Council  
22 on the 8th. day of February , 1989 at a meeting at which a quorum  
23 was present with a vote of 1,523.0 for; -0- against; -0- not  
24 voting; and 117.0 absent, pursuant to the powers vested in the  
25 Council by Section 1 (d) of Article VI of the Constitution of  
26 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
27 on January 18, 1986, and approved by the Acting Deputy Assistant  
28 Secretary - Indian Affairs (Operations) on March 6, 1986,  
29 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
30 984).
