

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Second Year Funding for the Title VII
Bilingual Education Program)

RES. NO. 45-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Tohono O'Odham Title VII Bilingual Education Program
3 under a three (3) year grant with the U.S. Department of
4 Education, Office of Bilingual Education and Minority
5 Languages Office; and

6 WHEREAS, the Tohono O'Odham Legislative Council is desirous to
7 continue to provide bilingual educational services to
8 the Tohono O'Odham Nation; and

9 WHEREAS, the Tohono O'Odham Title VII Bilingual Education Program
10 has submitted a budget for second year funding for
11 review and approval by the Tohono O'Odham Legislative
12 Council.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that the Tohono O'Odham Nation will not fund or
15 operate the program in the interim while negotiations
16 are still being conducted and no executed grant has been
17 awarded by the U.S. Department of Education, Office of
18 Bilingual Education and Minority Languages.

19 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
20 that the Tohono O'Odham Nation's Officials, to wit: the
21 Chairman, Vice Chairman and any designated official are
22 hereby authorized to negotiate and execute the grant,
23 provided however, that any amendments affecting the
24 funding or funding levels of the grant shall be
25 submitted for further prior approval by this Council.

27 The foregoing Resolution was passed by the Tohono O'Odham Council
28 on the 8th. day of February, 1989 at a meeting at which a quorum
29 was present with a vote of 1,465.0 for; -0- against; 58.0 not
30 voting; and 117.0 absent, pursuant to the powers vested in the
31 Council by Section 1 (f) of Article VI of the Constitution of
32 the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
