- WHEREAS, the Tohono O'Odham Nation is presently operating the Tohono O'Odham Title VII Bilingual Education Program under a three (3) year grant with the U.S. Department of Education, Office of Bilingual Education and Minority Languages Office; and
- WHEREAS, the Tohono O'Odham Legislative Council is desirous to continue to provide bilingual educational services to the Tohono O'odham Nation; and
- WHEREAS, the Tohono O'Odham Title VII Bilingual Education Program
 has submitted a budget for second year funding for
 review and approval by the Tohono O'odham Legislative
 Council.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative

 Council that the Tohono O'Odham Nation will not fund or

 operate the program in the interim while negotiations

 are still being conducted and no executed grant has been

 awarded by the U.S. Department of Education, Office of

 Bilingual Education and Minority Languages.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 8th. day of February , 1989 at a meeting at which a quorum was present with a vote of 1,465.0 for; -0- against; 58.0 not voting; and 117.0 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
