

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Additional Funds for Legal Fees and Expenses)

RES. NO. 46-89

1 WHEREAS, the Legislative Council did by Resolution No. 259-88
2 authorize the execution of a General Counsel Contract
3 for the extension of employment of the law firm of
4 Strickland & Altaffer, P.C. as General Counsel for the
5 Tohono O'Odham Nation and did authorize the payment of
6 legal fees and expenses incurred thereunder in an amount
7 not to exceed \$100,000.00 for the contract year; and

8 WHEREAS, the \$100,000.00 limit on fees and expenses set in the
9 contract was a temporary one and is \$150,000.00 below
10 similar limits set in previous General Counsel contracts
11 for the same or equivalent terms and services; and

12 WHEREAS, the Legislative Council has been advised that nearly all
13 the funds authorized by the contract have been
14 exhausted and it is necessary for the Council to approve
15 additional amounts to cover the services provided for in
16 the contract.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
18 Council that it does hereby authorize an increase of
19 \$150,000.00 to a total amount of \$250,000.00 to cover
20 fees and expenses incurred for services rendered by the
21 firm of Strickland & Altaffer, P.C. pursuant to the
22 provisions of the General Counsel Contract dated
23 September 24, 1988, Symbol No. H50C1420, Contract No.
24 7337.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 8th. day of February, 1989 at a meeting at which a quorum
27 was present with a vote of 1,402.0 for; 121.0 against; -0- not
28 voting; and 117.0 absent, pursuant to the powers vested in the
29 Council by Section 2 (a) of Article VI of the Constitution of
30 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
