

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing Expenditure of P. L. 99-503 Funds for  
Improvements to San Lucy Farms)

RES. NO. 47-89

1 WHEREAS, the Farming Authority ("Authority") of the Tohono  
2 O'Odham Nation manages and operates the San Lucy Farms  
3 ("Farms") which were acquired by the Nation pursuant to  
4 the provisions of P. L. 99-503; and

5 WHEREAS, the Authority has proposed a budget of \$83,090.00 to  
6 improve housing on and transportation to the Farms,  
7 which budget was reviewed by the San Lucy District  
8 Council and was by Resolution No. 12-40-88 conditionally  
9 approved at a funding level of \$73,090.00, to be funded  
10 with funds available under P. L. 99-503.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
12 Council that it does hereby approve the attached budget  
13 proposed by the Authority in the sum of \$73,090.00 for  
14 repairs and improvements to housing and transportation  
15 to the San Lucy Farms, to be funded with funds available  
16 for relocation and Economic Development, under P. L.  
17 93-503 which funds are hereby appropriated to the  
18 Authority, upon the following terms and conditions:

- 19 1. Expenditures shall be made only, pursuant to the  
20 approved budget for repairs to housing at San Lucy  
21 Farms, and for the acquisition of property and  
22 equipment for San Lucy Farms.
- 23 2. Operation and maintenance of all acquired property  
24 and equipment shall be the responsibility of the  
25 Authority.
- 26 3. The Authority shall provide monthly reports of  
27 expenditures made from and balances remaining in the  
28 account, to the Chairman of the District Council, and  
29 the Treasurer of the Tohono O'Odham Nation.
- 30 4. All unexpended funds remaining in the account after  
31 September 30, 1989 shall be returned to the San Lucy  
32 District P. L. 99-503 Account, or if any extension  
after September 30, 1989 is requested it shall be  
approved by the San Lucy District Council, and the  
Tohono O'Odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Council  
on the 9th day of February, 1989 at a meeting at which a quorum  
was present with a vote of 1,523.0 for; -0- against; 117.0 not  
voting; and -0- absent, pursuant to the powers vested in the  
Council by Section 1 (d) of Article VI of the Constitution of

1 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
2 on January 18, 1986, and approved by the Acting Deputy Assistant  
3 Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
