WHEREAS, the Authority has proposed a budget of \$83,090.00 to improve housing on and transportation to the Farms, which budget was reviewed by the San Lucy District Council and was by Resolution No. 12-40-88 conditionally approved at a funding level of \$73,090.00, to be funded with funds available under P. L. 99-503.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the attached budget proposed by the Authority in the sum of \$73,090.00 for repairs and improvements to housing and transportation to the San Lucy Farms, to be funded with funds available for relocation and Economic Development, under P. L. 93-503 which funds are hereby appropriated to the Authority, upon the following terms and conditions:

- 1. Expenditures shall be made only, pursuant to the approved budget for repairs to housing at San Lucy Farms, and for the acquisition of property and equipment for San Lucy Farms.
- 2. Operation and maintenance of all acquired property and equipment shall be the responsibility of the Authority.
- 3. The Authority shall provide monthly reports of expenditures made from and balances remaining in the account, to the Chairman of the District Council, and the Treasurer of the Tohono O'Odham Nation.
- All unexpended funds remaining in the account after September 30, 1989 shall be returned to the San Lucy District P. L. 99-503 Account, or if any extension after September 30, 1989 is requested it shall be approved by the San Lucy District Council, and the Tohono O'Odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 9th. day of February , 1989 at a meeting at which a quorum was present with a vote of 1,523.0 for; -0- against; 117.0 not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of
