- WHEREAS, the Budget and Finance Committee has reviewed the Consumer Price Index change for the prior calendar year and the rate of inflation continues in excess of four (4) percent; and
- whereas, the Committee recommends to the Council that the wage and salary levels of all employees of the Nation be increased by five (5) percent for the fiscal year beginning October 1, 1989; and
- WHEREAS, the cycle for renewal of grant and contract applications for FY 1990 has started for programs on funding year cycles different from the Nation's fiscal year, and approval of the wage and salary increase at this time will simplify the budgeting process for all contracts and grants for Fiscal Year 1990.
- NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'Odham Nation approves wage and salary increases in the amount of five (5) percent for all Nation's employees for fiscal year 1990. This increase shall take effect on October 01, 1989.

The foregoing Resolution was passed by the Tohono O'odham Council on the 9th. day of February , 1989 at a meeting at which a quorum was present with a vote of 1,424.0 for; -0- against; 216.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
