

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriation Priority List FY '90)

RES. NO. 51-89

1 WHEREAS, the Tohono O'Odham Legislative Council has appointed a
2 special delegation of Legislative Council
3 Representatives to travel to Washington, D.C. to testify
4 before the appropriation Congressional committees on the
5 President's FY 90 Budget; and

6 WHEREAS, it is to the Nation's advantage to prioritize the areas
7 and programs that the Nation will request Congress to
8 consider in its appropriation hearings; and

9 WHEREAS, this listing of programs is not exhaustive and is
10 intended to aid the Congress in considering the Tohono
11 O'Odham Nation's requests; and

12 WHEREAS, the Tohono O'Odham Legislative Council established ten
13 (10) programs as the top priority based on the need and
14 type of services provided to the people.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
16 Council that it does hereby list the following programs
17 in order of priority and respectfully urges Congress to
18 view these ten (10) as top priorities for the Tohono
19 O'Odham Nation and appropriate such funds that will
20 bring all ten (10) programs to an exemplary level of
21 funding:

Acting Deputy Assistant Secretary - Indian Affairs (Operations)
on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
