

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appropriating \$20,000.00 for the Development of a  
Multiple Attorney Contract System)

RES. NO. 58-89

1 WHEREAS, in August of 1988 the Domestic Affairs Committee  
2 submitted to the Budget and Finance Committee a request  
3 for funding the effort to develop a "multiple attorney  
4 contract system"; and

5 WHEREAS, there is a need to make specific and concrete the  
6 "multiple attorney contract system" proposal so that it  
7 can be fully considered; and

8 WHEREAS, fulfilling this need requires a special appropriation  
9 for the purpose of retaining a "Special Counsel on  
10 Counsel" under the supervision of the Domestic Affairs  
11 Committee; and

12 WHEREAS, the Budget and Finance Committee on February 6, 1989  
13 recommended unanimously that such a special  
14 appropriation be made.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Nation that:

- 16 1. For fiscal year 1989 the sum of \$20,000.00 is hereby  
17 appropriated to retain a Special Counsel on Counsel  
18 under the supervision of the Domestic Affairs  
19 Committee;
- 20 2. The duties of the Special Counsel on Counsel shall be  
21 to:
- 22 - investigate and develop further the multiple  
23 attorney contract system proposal
  - 24 - present legislation, including proposed attorney  
25 contracts, required to implement the multiple  
26 attorney contract proposal;
- 27 3. The Domestic Affairs Committee and the Judiciary  
28 Committee are authorized to negotiate a "Special  
29 Counsel on Counsel" contract with an appropriate  
30 legal practitioner and present the contract for  
31 approval through the required constitutional process.

The foregoing Resolution was passed by the Tohono O'odham Council  
on the 10th. day of February, 1989 at a meeting at which a  
quorum was present with a vote of 1,399.0 for; -0- against; -0-  
not voting; and 241.0 absent, pursuant to the powers vested in  
the Council by Section 1 (c), (2), & (f) of Article VI of the  
Constitution of the Tohono O'odham Nation, adopted by the Tohono  
O'odham Nation on January 18, 1986, and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March  
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
Stat. 984).
