  - 4. Schuk Toak District San Pedro Community Well Construction; and
- whereas, the Tohono O'odham Legislative Council had determined it is in the best interest of the Nation to apply for Community Development Block Grant Program funds for the purpose of the above-projects; and
- whereas, the specific Districts/Communities have passed resolutions and adopted policies regarding implementation of these projects.
- NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative

  Council does recognize and accept those resolutions and
  policies implemented by the Districts/Communities, as
  regards the application for and completion of these
  projects.
- BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the Chairman, Vice Chairman to consult with and negotiate for Community Development Block Grant funding to execute any and all contracts and legal documents and any amendments thereto which may be necessary to implement the projects.
