

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Request for Housing Improvement Program)

RES. NO. 73-89

1 WHEREAS, the Tohono O'odham Nation has a membership of 16,500;  
2 and  
3 WHEREAS, the Tohono O'odham Nation is participating in the Bureau  
4 of Indian Affairs Home Improvement Program (HIP); and  
5 WHEREAS, the Tohono O'odham Nation has listed elderly and  
6 handicapped people high priority for assistance; and  
7 WHEREAS, the Tohono O'odham Nation has successfully constructed  
8 over 200 Category "D" homes up to January, 1989; and  
9 WHEREAS, the Tohono O'odham Nation has an unmet need of 2,300  
10 additional new units or rehabilitation of units; and  
11 WHEREAS, the Tohono O'odham Nation has up to 35% to 45% of its  
12 units in need of adequate water and sanitary facilities.  
13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
14 Council that the Bureau of Indian Affairs be required to  
15 adequately fund at a level to meet the needs of the  
16 Tohono O'odham Nation.

17 The foregoing Resolution was passed by the Tohono O'odham Council  
18 on the 28th day of February, 1989 at a meeting at which a  
19 quorum was present with a vote of 1,577.0 for; -0- against;  
20 63.0 not voting; and 02 absent, pursuant to the powers vested  
21 in the Council by Section 1 (c), (2), & (j) of Article VI of the  
22 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
23 O'odham Nation on January 18, 1986, and approved by the Acting  
24 Deputy Assistant Secretary - Indian Affairs (Operations) on March  
25 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
26 Stat. 984).
