RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Requesting Increased Federal Appropriations for Indian Housing)

RES. NO. 76-89

WHEREAS, the most recent survey conducted by the Bureau of Indian Affairs of American Indian Housing reveals that 93,000 new or substantially rehabilitated houses were needed in 1987 in order to meet minimum federal housing standards, while a similar survey conducted in 1970 revealed that only 63,000 were needed; and

WHEREAS, the deterioration of Indian Housing is closely reflected in the gradual erosion of federal appropriations therefor from \$898 million in 1980, to \$148 million in 1988; and

WHEREAS, the Office of Management and Budget proposes by its FY
1990 budget "passback" to completely eliminate funding
for Indian Housing in the federal FY 1990 budget; and
WHEREAS, such action would have a drastic and irreversible effect

on an already critical and deteriorating situation.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative

Council that it does hereby urgently request that

Congress reverse the trend since 1980 of allowing the

erosion of support and appropriations for Indian

Housing, and increase federal appropriations so as to

reach or exceed 1980 levels, until Indian Housing meets

minimum federal housing standards.

BE IT FURTHER RESOLVED that the Legislative Council does hereby request the support of Congress, and specifically of its Arizona delegates, to increase appropriations for Indian Housing, and does hereby authorize and direct the Appropriations Committee, the Chairman and other appropriate officers of the Tohono O'odham Nation to seek support for and implementation of this resolution.
