7	WHEREAS,	in 1984 a bill, H.R. 4745 was submitted to Congress on

9		Nation in order to set aside federal land for their
10		benefit; and
11	WHEREAS,	the Hia-Ced O'odham have proposed federal legislation
12		which would transfer and reserve all vacant Bureau of
13		Land Management lands in the Ajo area for the use and
14		occupancy of Sand Papagos and as an addition to the
15		Tohono O'odham Nation, to become the twelfth district of
16		the Nation; and
17	WHEREAS,	the Tohono O'odham Nation by this resolution serves
18		notice to Congress that the Sand Papagos/Hia-Ced O'odham
19		are still in dire need of a homeland and that it will
20		continue its efforts to accommodate the people.

22		Council that the Tohono O'odham Nation hereby reaffirms
23		its support and continued assistance to the Sand
