RES. NO. 80-89

1 Xavier District Administration has negotiated a WHEREAS, the San fair value with El Paso Natural Gas Company for the Twin Buttes right-of-way contained on 643.4 rods of tribal land and 1664.0 rods of allotted lands within the 5 boundaries of the San Xavier Reservation; and WHEREAS, the Legislative Natural Resources Committee was apprised 7 of the San Xavier District's actions and negotiations

WHEREAS, there are currently no provisions within the Tohono O'odham Government system that specifically addresses rights-of-way distributions; and

regarding this renewal; and

WHEREAS, the legal opinion provided by the Tohono O'odham Nation's legal counsel is that the Nation's current Lease Ordinance has no bearing on rights-of-ways.

THEREFORE, BE IT RESOLVED that the Tohono O'odham Legis-NOW, lative Council hereby approves and supports San Xavier District Resolution No. 02-89-03, requesting all tribal proceeds stemming from El Paso Natural Gas Company's Twin Buttes right-of-way renewal.

BE IT FURTHER RESOLVED that upon receipt of this resolution, the Bureau of Indian Affairs is authorized to disburse all tribal funds acquired from this renewal to the San Xavier District, and for each year thereafter to the pursuant to Tohono O'odham Legislative year 2008, Council Resolution No. 79-89, "Approving El Paso Natural Gas Twin Buttes Right-of-Way on the San Xavier Reservation."

The foregoing Resolution was passed by the Tohono O'odham Council 1989 at a meeting at which a 28th day of February on the quorum was present with a vote of 1,111.0 for; 413.0 against; 116.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 2 (d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham tion of January 18, 1986, and approved by the Acting Deputy Secretary - Indian Affairs (Operations) on March 6, the Acting Deputy Assistant Secretary 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
