(O'Odham In Mexico Budget Amendment FY '89)

1 WHEREAS, the O'Odham In Mexico are continuing to defend the
2 rights of our O'Odham in reference to land; and


3 WHEREAS, it is necessary to hire a consulting attorney to assist
4 the O'Odham In Mexico by providing advice on the course
5 of legal action necessary to prevent non-O'Odham from
6 taking their lands; and

7 WHEREAS, it is necessary to amend the O'Odham In Mexico's budget
8 in order to hire a consulting attorney.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
10 Legislative Council hereby amends the O'Odham In Mexico
11 budget in the amount of \$3,000.00 .

12 The foregoing Resolution was passed by the Tohono O'odham Council
13 on the 3rd. day of March , 1989 at a meeting at which a quorum
14 was present with a vote of 1,640.0 for; -0- against; -0- not
15 voting; and 02 absent, pursuant to the powers vested in the
16 Council by Section 1 (d)(3) of Article VI of the Constitution of
17 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
18 on January 18, 1986, and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986,
20 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
21 984).


