

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Base Roll Additions)

RES. NO. 96-89

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the  
2 Tohono O'Odham Nation provides that the Tohono O'Odham  
3 Council can make additions and changes to the official  
4 census rolls of the Sells and Gila Bend Reservations  
5 dated January 1, 1937 and of the San Xavier Reservation  
6 dated January 1, 1940, subject to the approval of the  
7 Secretary of the Interior; and

8 WHEREAS, the Enrollment Committee has determined that the  
9 following named person was a member of the Tohono  
10 O'Odham Nation on the date of the respective census  
11 rolls but that their name had been inadvertently  
12 omitted therefrom, and have recommended that their name  
13 be added to the rolls; and

14 WHEREAS, the Tohono O'Odham Council has reviewed the recommend-  
15 ations of the Enrollment Committee and approves thereof.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council  
17 that, subject to the approval of the Secretary of the  
18 Interior, the name of the following person be added to  
19 the official census rolls of the Sells, Gila Bend or San  
20 Xavier Reservation, to wit:

21 165-ND-87 JUAN, Lewis

22 BE IT FURTHER RESOLVED that the required approval be secured from  
23 the Secretary of the Interior before their name be  
24 formally added to such rolls.

25 The foregoing resolution was passed by the Tohono O'odham  
26 Council on the 11th day of April 1989, at a meeting at which a  
27 quorum was present with a vote of 1,374.0 for; -0- against;  
28 181.0 not voting; and 85.0 (05) absent; pursuant to the powers  
29 vested in the Council by Section 1 (a) of Article II and Section  
30 1 (h) of Article VI of the Constitution of the Tohono O'odham  
31 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986,  
32 and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
