(Enrollment - April)

9 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that
10 the above named applicants are eligible for enrollment
11 as members of the Tohono O'Odham Nation under Section
12 1(a) or (b) of Article II of the Constitution of the
13 Tohono O'Odham Nation, and that their applications are
14 approved, as herein above indicated.

15 BE IT FURTHER RESOLVED that the Chairman and other appropriate
16 officers of the Tohono O'Odham Nation reduce this final
17 determination in writing regarding each of the foregoing
18 applications for enrollment in accordance with Section 3
19 (c) of Article III of the Enrollment Ordinance; give
20 notice of this Council's determination in accordance
21 with Section 4 of Article III of the Enrollment
22 Ordinance; and place the names of each applicant upon
23 the membership roll of the Tohono O'Odham Nation in
24 accordance with Article V of the Enrollment Ordinance.

25 The foregoing Resolution was passed by the Tohono O'Odham Council
26 on the 11th day of April, 1989 at a meeting at which a quorum
27 was present with a vote of 1,434.0 for; -0- against; 121.0 not
28 voting; and 85.0 (03) absent, pursuant to the powers vested in
29 the Council by Section 1 of Article II and of Section 1 (h) of
30 Article VI of the Constitution of the Tohono O'Odham Nation,
31 adopted by the Tohono O'Odham Nation on January 18, 1986 and
32 approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986 pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
