

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adoption into the Tohono O'Odham Nation)

RES. NO. 98-89

1 WHEREAS, Bartolo SINUHUI-SANCHEZ 164-ND-85 has made application  
2 for adoption in the Tohono O'Odham Nation pursuant to  
3 Section 2 of Article II of the Constitution of the  
4 Tohono O'Odham Nation; and

5 WHEREAS, the Enrollment Committee has reviewed this respective  
6 application, and has made a final determination that he  
7 is 1/2 degree or more of Papago-Tohono O'Odham Indian  
8 blood, and have made a recommendation to the Tohono  
9 O'Odham Council that his application be approved, all in  
10 accordance with the provisions of the Enrollment  
11 Ordinance; and

12 WHEREAS, the Tohono O'Odham Council has reviewed the recom-  
13 mendation of the Enrollment Committee and the evidence  
14 submitted in support of the individual's application.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that  
16 the application for adoption filed by:

17 SINUHUI-SANCHEZ, Bartolo 164-ND-85

18 is hereby approved and he is hereby adopted into  
19 membership of the Tohono O'Odham Nation.

20 The foregoing Resolution was passed by the Tohono O'odham  
21 Council on the 11th day of April, 1989, at a meeting at  
22 which a quorum was present with a vote of 1,074.5 for; -0-  
23 against; 480.5 not voting; and 85.0 (03) absent; pursuant to the  
24 powers vested in the Council by Section 2 of Article II and  
25 Article VI Section 1 (h) of the Constitution of the Tohono  
26 O'odham Nation, adopted by the Tohono O'Odham Nation on January  
27 18, 1986, and approved by the Acting Deputy Assistant Secretary-  
28 Indian Affairs (Operations) on March 6, 1986, pursuant to  
29 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
